The City Council of the City of Southmayd, Texas met on this date at 6:00 p.m. for a regular City Council meeting. # A. CALL TO ORDER & Declaration of a Quorum:

Mayor Thompson called the City Council meeting to order at 6:00 p.m., October 15, 2024.

Mayor Pro Tem Horstman made a motion to approve the consent agenda and department reports. Councilmember Everett seconded the motion, and the motion passed unanimously.

# 1. Mayors Report

Discussion only. No action taken.

Councilmember Byler made a motion to move the Executive Session before the regular agenda items and then move forward with the regular agenda. Councilmember Everett seconded the motion, and the motion passed unanimously.

### H. REGULAR AGENDA

1. Discuss, consider, and possible action on presentation of the September 2024 financial statements and report of account by Joe Madden, CPA.

Councilmember Everett made a motion to approve the September 2024 financial statements. Councilmember Miller seconded the motion, and the motion passed unanimously.

2. Discuss, consider, and possible action selecting a date/time for a public hearing to adopt the 2021 International Building Code, Residential Code, Plumbing Code, Mechanical Code, Fire Code, and the 2020 Electrical Code.

Councilmember Everett made a motion to publish notice of a public hearing in the Sunday's paper (October 19, 2024) of the Herald Democrat and to hold a public hearing on October 28, 2024, at 5:00 pm. Councilmember Tanner seconded the motion, and the motion passed unanimously.

3. Discuss, consider, and possible action regarding the lot size for residential homes.

Councilmember Everett made a motion to place a 90-day moratorium on any issuance of building permits for any new construction and to plan a special meeting with the city council and planning & zoning to review building ordinances within 30 days. Councilmember Byler seconded the motion, and the motion passed unanimously.

4. Discuss, consider, and possible action on passing Ordinance 460 to allow food trucks within city limits.

Councilmember Everett made a motion to table Ordinance 460 regarding food trucks within city limits. Councilmember Byler seconded the motion, and the motion passed unanimously.

5. Discuss, consider, and possible action regarding the yearly water bill increase.

Discussion only. No action taken.

6. Discuss, consider, and possible action regarding the Interlocal Agreement from Grayson County and estimate from RK Hall for cold mix to repair potholes.

Councilmember Everett made a motion to accept the Interlocal Agreement from Grayson County in the amount of \$850.50 and the estimate from RK Hall in the amount of \$4,160.00 for cold mix to repair potholes. Councilmember Tanner seconded the motion, and the motion passed unanimously.

7. Discuss, consider, and possible action on estimate from Clayton McKinney to install the water line at Pop's Park.

Councilmember Everett made a motion to approve the estimate from Clayton McKinney for the installation of a waterline at Pop's Park in the amount of \$1,900.00. Councilmember Tanner seconded the motion, and the motion passed three (3) to one (1). Councilmember Byler abstained.

8. Discuss, consider, and possible action on selecting a location, date, and time for the City of Southmayd Christmas Party.

Councilmember Byler made a motion to hold the City of Southmayd Christmas Party at the Southmayd Community Center on December 10, 2024, at 6:00 p.m., and to have BBQ catered. Councilmember Tanner seconded the motion, and the motion passed unanimously.
