#### REQUEST FOR DRIVER'S SAFETY COURSE

You may qualify to take a driving safety course if you have not taken one in the 12 months preceding this citation. You are NOT eligible if you are cited for speeding 25 or more over the limit, have a commercial driver's license, have an out-of-state license, speeding in a construction zone, passing a school bus or emergency vehicle, disregard stop sign, or leaving the scene of an accident. Wrong way drivers or failed to stop. No ins. At the time of stop.

The following items must be submitted to the court on or before the appearance date shown on the citation to be eligible to take the course:

- Court costs of \$144.00, IF IN SCHOOL ZONE \$169.00.
- 2. Complete and return "Options/Plea" page and "Request for Driving Safety Course" page of this pamphlet.
- Copy of your Texas driver's license and current proof of insurance, listing you as a covered driver. Military personnel and their dependents may submit a copy of their state driver's license and military identification card.

Once we receive the items noted above, we will send you an email with the instruction letter. You will then have 90 days to complete a Texas Education Agency approved course, and to present your certificate of completion and 3A driving record (DR). If you fail to take the course in the allotted time required and/or fail to present the court with any of the required documents, the court will change the disposition to a CONVICTION on the driving record and you will be required to pay the remaining balance of the citation. This pamphlet is provided as a courtesy to assist you in resolving the charge filed against you. Depending on the violation, some of your options may include pay the citation in full (points/surcharge fees may be assessed by DPS), request to take a driver's safety course for dismissal, request deferred disposition (probation) for dismissal, or plead "not guilty" and request a trial. In addition, some violations may be dismissed with proof of compliance requiring a \$20.00 dismissal fee. All these options are discussed in more detail inside this pamphlet.

# The Police Department must first file the charge with the court before we can assist you. Please WAIT TWO BUSINESS DAYS before appearing or calling.

Failure to make a proper appearance by your due date will result in additional fees/OMNI hold being placed on your Driver's License. Your court date is provided on your citation. It states that you **promise to appear** "on or before" and a date is provided. **You must contact the court no later than the court date provided on the citation.** 

## SPECIAL INSTRUCTIONS FOR JUVENILES AND MINORS JUVENILES (16 and under)

All defendants 16 years or younger are required to appear before the judge with a parent or legal guardian.

#### **MINORS (17-20)**

Minors charged with alcohol / tobacco /drug paraphernalia / theft or disorderly conduct offenses must also appear before the judge. If you are under the age of 18, you must appear with a parent or legal guardian.

#### COMPLIANCE DISMISSALS

No Insurance (Failure to Maintain Financial Responsibility): Citations for no proof of insurance will be dismissed at no charge upon presentation to the court of proof the driver or vehicle (if you had the owner's permission to drive their vehicle) was covered by a valid liability insurance policy at the time cited. Insurance coverage will be verified. Only if you had insurance at the time of the stop will it be dismissed, we will call to verify

**Expired Registration:** Court may dismiss with a \$20.00 fee IF renewed within 7 days of the citation, and you provide a copy of the tag receipt to the court. If your registration is out for over 6 months you will have to pay full price

**Failure to Display Registration:** Court may dismiss with \$20.00 fee if tag was current and if registrations in properly placed on vehicle.

**Expired Driver's License**: Court may dismiss with \$20.00 fee, IF renewed within 7 days of the citation, and you provide a copy of your new license to the court no later than your due date. If your D.L. is over 6 months you will have to pay full price

Fail to Display Driver's License: Court may dismiss a \$20.00 fee upon presentation of a driver's license that was valid at the time the citation was issued.

Fail to Report Change of Address/Name: Court may dismiss with \$20.00 fee if change of address is filed with the DPS within 7 days. Proof required. If it is over 6 months you will have to pay full price

**Equipment Violation:** Court may dismiss with \$20.00 fee if violation is corrected prior to appearance date listed on citation. Proof required. Not applicable if operating a commercial motor vehicle.
